How to set up a standing order

Setting up standing orders is easy.

Standing orders can be set up through your Online Banking, telephone banking or by completing the form overleaf and sending it or taking it in to your local branch. Information you will need to provide includes:

- Your account number and sort code
- The frequency of the payment and the amount
- When the payments should start
- The name and account details of where you are sending money to

How to cancel a standing order

Cancelling regular payments you no longer wish to make is easy.

If you bank online you can log into your account and select the 'cancel a standing order' option. Alternatively you can cancel your standing order via telephone banking, or in person at the branch.

Please ensure you provide at least two working days' notice prior to your next payment date.

Standing Order

A standing order is also an automatic regular payment but the amount is fixed. You set it up and only you can change it—for example, to change the amount or payment date. Rent, mortgage payments or charity contributions are often paid by standing order. You can also set up a standing order to your savings account if you want to save regularly.
